SUBJECT: October 2024 Monthly Report

The month of October was an extremely busy month for the members of the WTMFD. With October being Fire Prevention month, the members spent the entire month providing presentations to Daycares, Pre-Schools, and Elementary Schools. This year's theme was "Smoke Alarms: Make them work for you!". We provided 23 presentations throughout the month visiting 1,739 children and 289 adults. We also provided fire extinguisher training to 183 employees at various businesses within the township this month. This was all done while still responding to 111 calls for service.

I am extremely proud of the men and women of the WMTFD who give their time and talents to ensure we provide a safe and educational program for all of our residents and quests of West Manchester Township.

TOWNSHIP EMERGENCY RESPONSES CONTINUED

- There was a total of 542 personnel that responded to the incidents with an average of 7 per incident. (Average does not include Duty Officer & Fire Police Only Calls). This is a 16.00% increase from last month.
- Year to date, a total of 6,299 personnel responded to the incidents.
- We are at a 6.04% increase in call volume from this time last year.

DEPARTMENT NEWS

• The WMTFD applied for the PA State Fire Commissioners grant in the amount of \$40,000.00. We are happy to report that the department has been approved for the grant and are currently waiting for the final dollar amount that we have been awarded. Awards should be released sometime in December or January.

RECRUITMENT & RETENTION

- For the month of October, we received a total of three (3) inquiries for membership.
- There were no physical meetings for membership during the month of October, however there were two (2) meetings via phone.
- There was a total of three (3) applications received for membership during October which will be voted on during the November meeting.

MAINTENANCE

During the month of October, the following maintenance was performed:

October 15, 2024 – Rescue 505 motor repairs due to an oil leak. It was found that the head, gaskets, and head bolts all needed to be replaced. The board authorized the expenditure of up to \$20,000.00 due to not being in the 2024 budget. After all repairs were made the final cost of the repairs was \$17,433.54. The rescue was out of service for 15 days for the repairs. The members of the WMTFD thank Township Manager Kelly Kelch and the Board of Supervisors for their continue support of the WMTFD and helping us maintain a top notch fleet.
