Police Chief's Report for November 2024

November 14th, 2024

Dear Board of Supervisors, Manager and staff,

For the month of November, the officers handled 445 incidents as well as 67 vehicle crashes. Officers conducted over 303 traffic stops and issues 115 traffic citations. The department made 18 felony arrests, 25 misdemeanor arrests, 9 summary non-traffic arrest and 3 juvenile petitions were also filed.

On October 2nd the department provided security for the Democratic candidate for vice president at the Fairgrounds. We worked directly with the secret service and other law enforcement entities around York County. I mentioned this in the last report, but it deserves to be mentioned in this report due to the large amount of resources that were involved.

The department has provided a full time offer to candidate Andrew Shaffer. Shaffer is a veteran of the US Airforce and is a college graduate. Shaffer will be attending the next police academy at HACC starting January 5th 2025.



CI Division Report for October 2024 Board Meeting

10/17/2024 through 11/7/2024

Since October 17, 2024, WMTPD Criminal Investigations has taken on 7 new case assignments: 2 PICS cases, a PFAD investigation for the relinquishment of firearms subsequent to a PFA Order, 3 ChildLine Referral cases for alleged sexual or physical abuse of children, and a fraud/theft by deception case for approximately a half million dollars involving the school district.

During the same time frame, our office has formally closed out 7 investigations: the 2 PICS cases listed above, the PFAD case listed above, and 4 investigations into physical/sexual abuse of children or alleged sexual exploitation of children.
